The Founders Fund, Inc. Holds Annual High School Counselor Breakfast

(*Naples, FL – February 3, 2010*) The Founders Fund, Inc. held its High School Counselor Breakfast on Wednesday, Feb 3^{rd} at The Club Pelican Bay. Attending the annual event were 11 Collier County High School guidance counselors.

The Founders Fund members in attendance were informed about the current standings of the schools' senior class from those people most involved with the students – their guidance counselors. Sue McNaghten, Founders Fund Scholarship Committee Chairperson, encouraged them to share their knowledge on the sizes of the graduating class, the anticipated financial need of the students, and experience with the difficulties facing college-bound seniors, most notably the need for support to pay for their education.

The Founders Fund scholarships are \$2000 each and may be renewed if the student maintains a B (3.0) grade average and has a financial need. Considered also on the application are co-curricular activities, honors and awards received, leadership, community volunteer involvement, and work experience.

In 2009, 25 Collier County students received the renewable award, becoming part of the 87 students receiving the support of The Founders Fund and attending vocational schools, colleges, and universities all across the country.

The Founders Fund, Inc., a non-profit, tax-exempt charitable organization, was created in 1991 by the Founding Golf Members of The CLUB at Pelican Bay. The mission is to provide financial assistance to young men and women from Collier County in their pursuit of higher education.
