## The Founders Fund, Inc. MISSION

The mission of this charitable activity of the members of The Club Pelican Bay is to provide financial assistance to young men and women from Collier County in their pursuit of post high school education and training. Recipients are selected on the basis of need and merit from the ten high schools of Collier County.

The Founders Fund was created in 1991 by the Founding Golf Members of The Club Pelican Bay, a private golf club. The Internal Revenue Service has classified the Founders Fund as a 501 (c) (3) non-profit, tax-exempt charitable organization.

The Founders Fund is supported by both Golf and Social Members of The CLUB, as well as many corporate sponsors which include prominent local and national businesses that are very generous in their support of the Founders Fund. Income from reserve assets and fundraising activities supports annual scholarship grants of approximately \$180,000 per year. Fund scholarship awards have totaled more than \$1,800,000.



#### Founders Fund Honors Scholarship Recipients

An impressive group of nearly 100 people attended the annual "Get Acquainted Luncheon" of The Founders Fund, Inc. on Friday, January 2. The event, held at The Club Pelican Bay, honored the current scholarship recipients of The Fund. Others in attendance were board members, committee chairs, benefactors, supporters, sponsors, and area high school guidance counselors.

The students addressed the Founders Fund members, informing them about their educational goals, accomplishments and career aspirations. They also thanked the members for their tuition assistance and described how the scholarships have aided them in their higher education schooling.

## Scholarship Breakfast held with Collier High School Guidance Counselors

The Founders Fund, Inc. held its annual High School Counselor breakfast on Wednesday, Feb 4th at The Club Pelican Bay. The annual event was attended by a majority of Collier County High Schools and was aimed at gathering information about the number of anticipated graduates at each school, a sense of current scholarship needs, special application instructions, and updates about The Founders Scholarship Fund. Several private schools were also represented at the morning event.

This year, students will be downloading scholarship applications for the first time from the Collier County Public School System. The process will give all Collier County seniors the opportunity to apply. However, just in case a student does not have access to a computer, school counselors will be helping students through the application process as usual.

The Founders Fund scholarships are \$2000 each and may be renewed if the student maintains a B (3.0) grade average and has a financial need. Students are asked to

#### It Pays to Get a College Degree

It really pays to continue education past high school. Students who attain a four year college degree gain not only higher education, but also higher future earnings. Statistics in 2008 showed that a student who graduates from a college or university will likely make 90% more in salary than a high school graduate.

On average, college graduates earn \$59,365 per year as compared to high school graduates who earn an average of \$33,609.

list their co-curricular activities, leadership, honors, awards, community service, and work experience on the application.

"We want to get to know the students and we feel that if a student is involved in leadership and their community as a teenager that they will thrive in college. We want to reward good grades and hard work," says Sue McNaghten, Scholarship Committee Chair.

In 2008, renewable annual scholarships of \$2,000 each were awarded to 25 students in Collier County High Schools. There are currently 94 students at 27 different colleges, universities, vocational schools, and professional programs supported by annual scholarships from the Founders Fund.

dent achievement is evidenced through not only her career choice, but her retirement decisions, as well. Judy spent many years working as a Career Center Coordinator in a Massachusetts regional high school, before retiring to Naples, with her husband Ed.

She and her husband moved to Naples and continued their efforts to assist students attain their educational dreams. Ed became an original member of the Founders Fund, planning and fundraising for its establishment. Through his involvement, Judy was exposed to the good works of the charitable organization and to the students who receive scholarships.

This led Judy to follow in Ed's footsteps and become a member of the Board of Directors for the Founders Fund. She served on the board from 2000-2006 and enjoyed getting to visit Collier County high schools and meet with guidance counselors and students.

Judy says, "A highlight each year was going to the area high schools and meeting with students who applied for the scholarships and interviewing them. We all would come back from these interviews and wish we could award each student we met."

She has high hopes for the future of the Founders Fund scholarship program and is pleased to see the enthusiasm and support grow each year. She believes that the six-year term for board members ensures continuity and community commitment to education.

Judy says, "It is a pleasure to see how our members continue to enthusiastically support the Founders Fund and the mission to Make Dreams Come True for so many deserving young people."

#### Rocky Caldwell



Rocky Caldwell knows what it is like to work hard and he enjoys seeing the younger generation also put forth the effort to get ahead and succeed in life. Caldwell rose to Senior Executive Vice President of Armstrong World Industries, Inc. in Lancaster Pennsylvania after 35 years with the company. Following his retirement in 1990, he didn't take a breather, instead he focused his efforts on helping young men and women from Collier County pursue their post high school education and training.

In 1991, Caldwell along with the other Founding Golf Members of The Club Pelican Bay, a private golf club began a new challenge, creating the non-profit Public Foundation that has become known as The Founders Fund, Inc. The charitable organization started with just \$100,000 in assets, but to date has given out \$1,800,000 in scholarships.

Caldwell says," I never thought the Fund would reach the size it has. It really has taken on a life of its own. Its continued growth is a tribute to the many devoted people who are involved with it."

He is proud that nearly all of the money generated by the Founders Fund goes directly toward scholarships. Only approximately one percent of the funds are spent on administrative expenses.

Caldwell says, "This makes it very attractive to members and donors. It is very gratifying to see members proud of what they are doing."

The Founders Fund is supported by Golf and Social Members of The Club Pelican Bay, as well as many corporate sponsors.

A founding member and six-time Past President of the Board of Directors, Caldwell no longer serves on the board, but remains very involved with the Fund's activities and continues to look ahead.

He says, "The future of the Fund depends on broad involvement from a diverse group of people. I hope it becomes a self-perpetuating organization continuing on forever, long after I am gone. The success of any organization depends on each person who comes along --to pick up, take what's there, add to it, and improve it."

## Founders Fund Helps Meet Rising Cost of Going to College

It continues to get more expensive for students to attain their college degrees. According to a report from the College Board (non-profit group that tracks college tuition), the average cost of tuition and fees for college students increased from \$108 to \$1,398 in 2008.

Private four-year \$25,143 (up 5.9 percent from prior year) Public four-year \$6,585 (up 6.4 percent from prior year) Public two-year \$2,402 (up 4.7 percent from prior year)

That means a family would shell out over \$26,000 for a four-year public college education and more than \$100,000 for a student's education at a private institution.

Note: Cost and aid figures are from the College Board's Trends in College Pricing 2008, Trends in Student Aid 2008, and Education Pays 2007.
