*The mission of this charitable activity of the members of The Club Pelican Bay is to provide financial assistance to young men and women from Collier County in their pursuit of post high school education and training. Recipients are selected on the basis of need and merit from the ten high schools of Collier County.*

*The Founders Fund was created in 1991 by the Founding Golf Members of The Club Pelican Bay, a private golf club. The Internal Revenue Service has classified The Founders Fund as a 501 (c) (3) non-profit, tax-exempt charitable organization.*

*The Founders Fund is supported by both Golf and Social Members of The CLUB, as well as many corporate sponsors which include prominent local and national businesses that are very generous in their support of The Founders Fund. Income from reserve assets and fundraising activities supports annual scholarship grants of approximately \$180,000 per year. Fund scholarship awards have totaled more than \$1,800,000.*

## Amazing facts about Collier County schools

- The School District of Collier County earned its first-ever "A" grade from the State of Florida Department of Education for the 2008-2009 school year. The District has maintained a "B" grade since 2004, when district grades were first given.
- At the end of the 2008-2009 school year, eight Collier County schools had made Adequate Yearly Progress (AYP) under the very stringent federal No Child Left Behind Act (NCLB) criteria.
- During the 2008-2009 school year, The School District of Collier County received assistance from more than 7,200 active and dedicated volunteers. They donated an amazing quarter of a million hours of service to the district's students and schools.
- Collier County high school students take college-level courses and earn college credit by taking Advanced Placement (AP) exams. Last school year, 2,136 students took 3,608 AP exams.
- English is not the first language for 15.4% of students in Collier County, with more than 6,500 students in the English Language Learners (ELL) program. Collectively, these students speak 81 different heritage languages and hail from 147 different countries of origin.
- Forty-four percent of Collier County students live in non-English speaking homes, where English is not the first language and sometimes isn't even spoken. The percentage increases to 52% in grades Pre-K through 3.
- The School District of Collier County is a recognized leader in Florida when it comes to technology. There are more than 24,000 networked computers in use district-wide.

## Florida college enrollment booms

Many students across the U.S. are opting to stay in-state to save on college costs.

Enrollment is up at 10 of the 11 state universities in Florida, and at an all-time high at eight of them. South Florida's three community colleges also have record enrollments.

Money is the big reason for the boom, officials say. Reacting to the recession, some students are pursuing more education if their job prospects are poor, while others are foregoing more expensive out-of-state or private schools.

The surging enrollment has meant tougher admissions standards. Most universities put no limits on qualified transfers or graduate students. Several schools, including Florida Atlantic University and the University of Central Florida in Orlando, reported drops in freshmen enrollment. Budget cuts prompted some to cap the number of freshmen they accepted, saying the state doesn't adequately fund the cost of educating them.

However, with increased overall enrollment, budget cuts, and no ability to expand class sizes, students sometimes find classes they want to get into wait-listed. Some are opting to pick online classes or classes later at night than they would normally want.

## Higher education equals higher earnings

The higher level of education, the higher the potential earnings. According to the College Board, over a lifetime the typical full-time worker with a four-year college degree will earn 60 percent more than a worker with only a high school diploma. In addition the amount of money earned continues to increase as the education increases. The organization says workers with master's degrees earn almost twice as much per year, and those with professional degrees earn almost three times as much as high school graduates earn over their working lives.

## Higher education helps in a recession

The statistics show that higher education not only means a bigger paycheck, but it also means a steadier income, as well. A report by the U.S. Department of Labor revealed that workers who continued their education past high school fared better in the recession. The unemployment rate for those with at least a bachelor's degree was 4.7% in July, but it jumped to 7.9% for workers with only some college or an associate degree. Those in the workforce with only a high school diploma saw a jobless rate of 9.4% and those with less education than that saw an unemployment rate of more than 15%.


## From our Scholarship Recipients

## Interviews with Our Founders

### Cheryl Cullen



Board Member Cheryl Cullen says the children and their need for advanced education are what keep her involved in The Founders Fund. She became involved with the organization in 1992 by joining the Board of Directors. In 1993, Cullen and Ed Brennan initiated a dinner with raffle prizes to raise additional funds for the scholarships. That dinner evolved into a golf tournament which now is the primary fundraiser for The

Founders Fund.

Cheryl says, "Who could have imagined that a dinner and raffle would have continued and grown to what it is today. Rocky Caldwell, the first Founders Chair, should be very proud of where we are today as I know the late Ed Brennan would be."

Cheryl and her husband Jack have lived in Pelican Bay since 1986, summering at New Seabury on Cape Cod. She has two sons and five grandchildren. Her involvement in educational opportunities for youth is not limited to The Founders Fund. She started by getting involved with a scholarship program at her sons' private school in Massachusetts and raising money for the Youth Hockey and then the Youth Soccer.

A 1993 diagnosis of Multiple Sclerosis and one year spent as a paraplegic didn't slow down Cheryl. She stayed involved with the Fund by working from her home.

She says, "Some of the children may never have an opportunity to attend school without our support. It is heartwarming to hear their stories and how we have helped them."

Though Cheryl retired as a Trustee in 2000, she still stays active at The CLUB by participating on the Board of Governors, serving as chairman of the Social Committee, and being a member of the Ladies Golf Committee.

Looking toward the future of The Founders Fund, Cheryl sees a continued and increased need among local high school students.

She says, "As Collier County continues to grow, I can see us expanding and handling future high schools. Especially in this economy, the students will need our assistance."

### Paul Slater - A True Fundraiser



A True Fundraiser, Paul Slater makes it his business to know the numbers, whether it is financing the restructuring of an international business or generating funds for The Founders Fund.

He serves as Chairman of First International Corporation, making his living as a private investment banker who specializes in the maritime transport and energy industries across the globe. Paul

and his wife Barbara have lived in Naples since 1989, spending 15 years at Pelican Bay before moving to Pelican Marsh.

Paul has been a member of The Club Pelican Bay since 1983 and led the team which bought The CLUB for the members from Westinghouse in 1990. As the initial Chairman of the Board of Governors for The Club Pelican Bay, he raised approximately \$150,000 from the members to fund legal and accounting expenses (which were refunded by Westinghouse on closing the deal.)

Upon the refund, Paul proposed to members that they use the monies to set up an educational fund to provide grants for the children of club employees. Club members unanimously agreed on the proposal and upon legal advice expanded the reach of the educational fund to include qualified applicants from all of Collier County.

Paul says, "The fund has grown tremendously since its inception. It gives members a chance to support the local community even though the majority of them are only here in the winters."

Paul believes that club member support of The Founders Fund is essential to its surviving and thriving in this turbulent and uncertain economy.

Paul says, "All charities face the problems of the huge losses of private capital coming out of the collapse of the banking markets and the economic recession. The Founders Fund needs continuing donations to maintain and expand its grants and must adjust to these new financial times ... and assume they will be with us for some years to come."

Paul knows the importance of a good education and understands the high financial cost to achieve it. He has served as a governor of a local private school, as a trustee of a university in Great Britain and is founding chairman of an industrial foundation which provides educational tools to people interested in the international shipping industry. He also has four sons who have all graduated from college.

He says, "Today the Fund needs to reconnect with the membership and explain its achievements and its objectives. A picture gallery of all our recipients and their stories would be a good start. Every new member should be given a brochure on the Fund and encouraged to donate."
