

My mother was a public school teacher until the age of 80. She instilled in me the belief that educating young people is vital to the strength of our society.

GIVING TUESDAY

We hope you will include Founders Scholarship Fund (FSF) in your plans for Giving Tuesday or your year-end charitable contributions. Donations are welcomed and appreciated throughout the year, every year.

While many individuals make charitable donations through a Donor Advised Fund, or as qualified charitable deductions from an IRA, tax practitioners are encouraging individuals who itemize deductions to consider accelerating donations into 2025. This is because of tax law changes beginning in 2026 which include:

- Itemized charitable deductions will be subject to a new floor of 0.5% of adjusted gross income (AGI). Therefore, the equivalent of 0.5% of AGI is a permanently lost deduction in 2026 and beyond. For example, if AGI is \$300,000, the first \$1,500 of charitable contributions will not be tax-deductible.

- For taxpayers in the top 37% tax bracket (\$768,781 for married filing joint returns), the tax benefit from all itemized deductions, including charitable contributions, will be capped at 35%.
